Citizen Demand for Investigation & Criminal Prosecution

Of All Judges in Ventura County's Superior Court

July 24, 2003

Dear Mr. Lockner

There has never been a time in the modern history of the state of California. Where the credibility of our government has been so doubted. We see it only in part with the recall election of Governor Davis pending. This however is only the tip of the iceberg of problems of a far greater magnitude.

The specific problem that I refer to is growing evidence of the manifest corruption of our courts and legal system in general. With our criminal justice system being the most corrupted. Many citizens are now beginning to realize that certain members of our legal establishment. Are turning our courts from temples of justice into headquarters for their various racketeering enterprises.

Where they have conspired one with another to abuse the system of justice. To fix the outcome of cases to favor the rich, powerful, the government or politically connected. In most criminal cases involving the average person. The so-called defense attorneys, court appointed or private provide no constitutional protections or only sham defenses.

They even withhold their protection and aid in the convictions of their innocent clients. By failing to investigate the case, obtain discovery, file required pre trial briefs on their own. They even fail and refuse to file lawful defense briefs professionally prepared by their clients.

They are only at best straw men warm bodies. Who give only a colorable compliance with the constitutional command for justice. They do this in order to protect the police, persecutors from the exposure of their wrong doings and criminal actions. Which allow the prosecution to win so as to advance their personal careers.

These so-called defense attorneys who are in fact just organs of the state. Who assist in obtaining the false and illegal convictions of their clients. For future favors or out of fear of relation. While this may shock you, the

evidence of this is indisputably preserved. In our files, the courts own records as well as the broken minds and bodies of those innocent people who's lives they have destroyed.

As for the prosecution they have a long custom of collusion with law enforcement and of flouting the law. They fabricate cases, plant, manufacturing, suppressing and withhold evidence from defendants. Engage in habitual lying to the public and in the courts. They also engage in the stealing of money and property and allow their friends and co-conspirators to do the same.

It is also their custom secure, buy, commit and suborning of perjury before the court. They use extortion to force guilty pleas from the innocent. They do so with the knowledge and assistance of their victims own defense attorney and their partners the judges.

Judges most who were previous prosecutors engaged in this type of practice themselves as government lawyers or failed prevent same. They consider this standard policy. As it has long ago become an institutionalized practice, custom, and tradition of these government lawyers.

I therefore make this ***criminal complaint*** against the legal establishment in Ventura County. Which includes all the Judges in the Ventura county superior court and their appellate dept. including but not limited to Judges Vincent J. O'neal Jr, Ken W. Riley, David W. Long, James Cloninger, John Smiley, Herbert Curtis 111.

Included in this conspiracy to violate rights under color of law is Ventura County District Attorney Michael Bradbury, VCDDA John Thomas Conners, Ventura county Public defenders' office, Conflict Defense Associates , their attorney Stinefield and Andrew M. Wolf, private Attorney Garret Zelen. To name only a few of the key players in this case. It is my opinion that the record is so strong that a first year law student will be able to obtain lawful and just conviction of these evil doers.

We feel that the information we have regarding the police state actions taken against our client Ms Ferguson and her family members is only the tip of the iceberg. Of the many victims of this manifest corruption of our legal system and the administration of justice. In the courts in Ventura County and elsewhere in California.

Attached you will find a copy of brief for the petition for rehearing at the appellate department of the Ventura County Superior Courts for our client Ms Ferguson. This will give you much of the background information and

additional evidence needed for your investigation and prosecution. Of who are in my opinion manifest evil doers and criminals hiding behind their office and in their black robes .

Which be a even greater cause embarrassment to your office and our state than the recall of governor Gray Davis is causing.
