## **Third Urgent and Expanded Demand for Investigation**

### **Criminal Prosecution OF Superior Court Judges**

#### **Prosecutor's & Police.**

We are writing you again for your urgent action to protect the people in the state of California from dangerous predators who have betrayed the peoples trust and hijacked our legal system. To use for their criminal and terrorist purposes. We again demand the Criminal Prosecution of these evil doers who are Superior Court Judges, Prosecutors & Police.

For their criminal acts of corrupting of California's Criminal Justice System. Who have been turning our rule of law. Into the rule of any lie that they can conjure up. With the Alice in Wonder Land syndrome being their controlling doctrine.

This doctrine holds that the truth and law is what ever they say it is. Changing in any given moment at their whim. To advance their personal or political agendas, or to cover up for their follow tyrants illegal acts. Who have turned our legal systems, our courts, and the administration of justice into their own racketeering enterprises.

On **July 24, 2003**, I filed a formal complaint with your office of public inquiry. You're staff following the custom of Californian's legal establishment. While acknowledging that my complaint, was regarding the widespread corruption of the courts in Ventura county. This fact is proven in the Renae Ferguson Case.

They willfully failed to take any action and instead further the coverup by (1) Stating that this complaint should be filed with (With the county Grand Jury) (2) They further stated if I though that a crime had been committed that I should report it to the district attorney.

This coverup letter failed to state that all grand juries are under the control of the government lawyers. That whenever a grand jury uses its authority to investigate or indites those that the power structure wants to protect. The government lawyers and judges conspire to protect them by calling them a rogue grand jury. They then illegally dismiss the grand jury indictment as is their custom.

This case as you know involves manifest and widespread corruption of the courts and legal system in Ventura and La counties. Including the District attorney's Michael and his staff and judges in that county.

It also includes the past la city attorney and his staff including many current deputy district attorneys especially Robert Ferber. As well as attorneys in the La County district attorneys office who have committed and suborned perjury. Who as a custom make fraudulent official fillings, false and fabricated criminal charges.

They deny their victims of all their rights. They extort false convictions of the innocence. They deny them assistance of counsel. Impartial judges, witness in their defense and railroad them though a corrupt legal process into prison. Which has long since become a pattern practice and custom of the legal establishment in California.

This specific conspiracy has been manufactured against Ms Ferguson by VCDA Michael Bradbury. Various lawyers, rouge law enforcement agents, prosecutors and judges. Which has been hidden by these evil doers and protected by a conspiracy of silence. By the lawyers and judges who profit as the result this corruption.

A motion was made for you to take over this case in the Ventura county leg of this conspiracy. Which you refused to do. You also had lawyers of you staff working side by side with the la city attorney's lawyers. Who personally witness the frauds, perjury, and obstruction of justice by the city attorney office. As well as that of trial judge Groneman in the airport case. Who did nothing to stop this evil and personally furthered it as the trial records proves.

**On August 16, 2003** I sent a further letter to you personally at your office in Sacramento Ca. By certified Mail # 7002 3150 0004 9484 8265. Which you received on August 26, 2003. As of this date we have received no response from you.

**Therefore, I am making with this letter an additional complaint. As well as a demand for prosecution of the following Judges and their co-conspirators. For which your immediate action is required to preserve the little remaining integrity of our legal system. That the damages to Ms Ferguson an the violation of her rights be stopped. As well as that these evil doers be brought to Justice.**

The judges at what is now the Airport court including trial Judge Groneman commissioner Gordon. Probation hearing **Judge William Ryan** and other judges who through acts or admission. Have furthered and compounded the violation of Ms Ferguson's rights under color of law.

They have also furthered the manifest conspiracy to undermining the governing rules of our nation. In this case regarding Ms Ferguson judge Groneman in our opinion did everything in his power. As the court record show to fix the outcome of this case.

Which Including conspiring with the prosecutors including DCA Robert Ferber. To obstruct justice as well as the courts truth seeking process. By threatening the lawyers for Ms Ferguson including prominent attorney Roger Diamond Who then told the judge on the record that he was afraid of him and then he

abandoned Ms Ferguson defense.

He further appointed Attorney Nancy Cunningham as attorney for Ms Craig who he then caused or allowed to work with the prosecution to convict her client. Who worked to sabotage the cases of the other defendants as the record shows. In fact none of these lawyers in this case made any meaningful defense motions including compelling discovery.

While their co-defendant who they had knowing also falsely charged. For the purpose of depriving Ms Ferguson and Craig of his expert legal knowledge. Who was defending himself as he knew that most lawyers are in fact agents of the state. Who in as a custom take their clients money and run making no defense or only sham defenses.

He while defending himself filed as many as one hundred different motions. He also caught the government attorneys, police and witnesses committing and suborning perjury over and over again. He did so in the presence of the trial judge and in open court. Judge Groneman furthered the governments criminal acts.

By covering up for them and threatening the defense lawyers as well as the defendants. When they attempted to hold the government lawyers accountable for their crimes. He further wilfully denied them witnesses in their defense. While allowing the government lie and to deceive the jury as the trial record indisputably proves. Thereby causing the conviction of the innocent defendants.

**Judge Ryan** who presided over Ms Ferguson probation violation hearing followed in this long lasting custom of judges. Who conspire to protect the prosecution & police in their criminal, unconstitutional acts. Including their pattern of obstruction of justice. He was made aware of the perjury of the City attorney and police, their false charges and saw DCA Robert Ferber committing perjury in his very presence.

He was also informed of the crimes of the La City police department including their stealing property and horses. Which they did with the knowledge and permission of the La City attorneys office. This judge however refused to bring them to justice. He instead continued with the political persecution of Ms Ferguson.

Which included issuing of a million and a half dollars bail bond for an alleged misdemeanor probation violation. Which was for driving on a suspended drivers licence. Which she knew nothing about, that was the result of an error by the DMV.

It is our opinion that this betrayal of the public trust by the lawyers/judges. At the airport court is just the tip of the iceberg. Of the corruption of our courts in California. Covered up by a conspiracy of silence by the legal establishment.

**The evidence** of this corruption has been continued over at the court in San Fernando court. Where Judge Meredith Taylor. Wilfully compounded this conspiracy by accepting a forced guilty plea from Ms Ferguson. When she knew that Ms Ferguson was being railroaded. That the fix was in as proven by the fact. That all of Ms Ferguson's lawyers had wilfully failed and refused to make any defenses or protect her rights. **(We have the evidence).**

Ms Ferguson had filed pro se motions herself informing the court of this and making her perfect defense. Which is that she was innocent of all these false charges. That a **demurrer** was filed, was pending, which was never ruled on. This deprived the court of jurisdiction over the merits of the charges. Judge Meredith Taylor also knew that the la police department officers had made false charges.

Were guilty of stealing horses. She knew as evidence in this case proved. That the LAPD had given the horses belonging to West Coast Riding Academy which was evidence in this case. To their agent Ms Ferguson competitor and private citizen Cathleen Doyle.

This was done as payment for her role in manufacturing this case. They did this before the case ever went to trial and without any court order. As the trial record at the airport court proves. Their removing this evidence out of police control. Is yet another in a long train of serious crimes by the government and their agents in this case.

Ms Dole also was at all times was an agent of the Ventura County District Attorney Michael Bradbury. As well as an agent of La police department. Who together conspired to manufacture this case for political purposes. To further a coverup of their collective criminal acts. As well as retaliation for her seeking judicial protection through, injunctive relief, and civil rights damage suites.

Judge Merdith Taylor furthermore accepted what she knew was a **coerced guilty plea**. That was obtained through black mail, extortion, force, fear, violence or the threat of same. For a fabricated offence that the facts before the court and on the face of the charges indisputably proved.

**(That it was impossible for to her to have committed.)** The False charges were that Ms Ferguson has stolen horses. When half of the horses in question had been the property of hers or West Coast Riding Academy Inc. for years.

The others had been given to this riding school. Therefore it is impossible to be guilty of stealing someone property when they no longer want it. Who also willing gave it to her, so that they would no longer have the burden of feeding or caring their horses.

The Government including the LAPD knowingly and willing solicited this perjury. From these so called complaining wittiness. Who gave horses of no value to them to west coast riding academy inc. Which is a not for profit religious educational corporation as they knew.

The making and filing false & manufactured complaints by the government and their agents. Is on its face is a crime. Which has been committed by the LAPD officers, La City Animal Control officers, and others. As well as those making the false complaints that Ms Ferguson had stolen their horses.

Who the government had further had enticed to make false allegation at staged media events. As well as published news stories. Where they alleged that certain horses were theirs. When in fact these horses had been the property of WCRA for as long as five years.

These staged media events were deigned to promote Michael Bradbury's , Cathleen Doyal's Robert Ferber's and others in the government & private sectors political and fanatical animal rights agendas . Including raising money, getting votes and campaign contributions. It also including the willful tampering with the jury pool, to prejudice and inflame the courts. As well as promoting their ballot proposition save the horses.

As the government and judge knew however the fix was in. This judge granted forced payment to those who had made these false claims. Without any hearing on the ownership of the horses in question or their value. However the evidence of the government stealing WCRA'S property was indisputable proven in the record.

Judge Merdith Taylor made a ruling forcing Ms Ferguson to make thousands of dollars in restitution to owners who considered their horses worthless and gave them away. The court further ordered Ms Ferguson to pay an additional fraudulent submission of expenses by the governments agent Cathleen Doyal.

When the airport court Judge Groneman had in the animal abuse case involving the same horses forced her and Ms Craig. To pay private citizen Cathleen Doyal the same money, for her alleged expense for care of the horses. Even though being convicted of allegedly not caring for only three of the horses. That belonged to West Coast Riding Academy Inc which the government had stolen.

This double billing for the same expenses is yet another illegal act in this long lasting conspiracy. They have also to this day refused to disclose. How much money they rased from the public that was donated to pay for the upkeep of these horses or who has these stolen horses.

This judge who in our opinion betraying her trust as a guarding of our liberty. Her duty to protect the integrity of our courts and the rule of law. While compounding the conspiracy to fix this case. She conspired to destroy Ms Ferguson so that the government could coverup for the corruption of VCDA Michael Bradbury, LAPD officers, Los Angeles City attorneys, their agents and co-conspirators.

As well as in my opinion to prevent the exposor of the corruption of our legal system. Which is a clear and present danger to all in this state. As we have no one to protect we the people from these dangerous super predators. Who have infiltrated every level of our government and legal system.

As the record shows that every attorney Ms Ferguson ever had has refused to protect her rights. Including pleading her guilty to a crime that she did not commit. Without even having her file in their possession including pending motions.

Facts that we have indisputably preserved in the courts records through our assisting Ms Ferguson with her investigation, pro se & friend of the court briefs. Testimony in open court, letters to the government informing them of this evil, and letters to her attorneys giving them evidence of her innocense.

The names of the lawyers who took her money or that the peoples and refused to make her many **defense's** includes but are not limited to the following.

***John Roger Diamond, Garret Zelen , Chet Taylor , Louisa Pensanti , Nancy Cunningham , Patricia Barry, Saria Willis, William Maxwell, Andrew Wolf . This includes the la county public defenders office, their alternative public defenders office The Ventura county public defenders and their second CDA office. Etc.***

Each and everyone of her lawyers failed or refused to make her perfect defense. Even after we had provided them with facts, law, wittiness, evidence and even professionally prepared legal briefs.

Your failure to immediately come to the aid of Ms Ferguson and to arrest, an prosecute these judges and other evil doers. Who have betrayed this nation and we the people. Will be indisputable evidence that your office is accessory to this corruption. That all convictions in this state have no credibility. That all must be retried in a lawful constitutionally required legal system.

That federal legal action will be required including civil rights damage suites, injunctive relief . As well as requiring that the U.S. Department of justice takes over California's courts. That we the people will be

forced to recall you. As we have done to the governor and get us new guards for our liberty. Who will bring to justice these lawyers & judges. Who are not only committing high crimes but high treason as well.

We have all the proof you need to purify our temples of justice and bring these evil doers to justice. If you demonstrate that you are serious about your duty. To we the people and justice not only will i provide you with all the evidence that you need to convict the criminals. I will also show you where the bodies an evidence, of other crimes of the same nature are buried.
